- A. FLVS is open to cloud hosted solutions.

Should MRCC include Turnitin license costs in our cost proposal, or should we assume that FLVS will provide the necessary licenses to support this requirement?

- A. FLVS has the necessary licenses.

Is the scope of this RFP just focused on the K-12 Online Schools that FLVS supports? Or, is this also intended to support the FlexPoint Education Cloud courses?

- A. The scope of this RFP is for all Florida Virtual School K-12 courses whether licensed through FlexPoint Education Cloud, used by Florida Virtual School direct students, or Florida Virtual School franchises.

Can you please expand on the structure of your organization to help us better tailor the implementation and services?

- a. Are the K-12 Online Schools that FLVS runs on the same student information system? If not, how many are in use?
- b. Are you expecting teachers to take any assessments in the solution, or just students?

- A. We support students from multiple learning management systems and student information systems.
- B. Just students for scoring purposes.

Is FLVS interested in ACT or SAT practice assessments as a part of this bid?

- A. Pilot in the upcoming school year with an agreed up on start date before school year 2023.

- A. We are flexible on the training model. The number will vary based on the model and solution provided.

- A. Any Vendor can submit this RFP. We will only contract with one proposer, which will be the one listed on the submission and who submitted in Bonfire, but they can subcontract with other vendors.
